

FREEBORN COUNTY SOIL & WATER CONSERVATION DISTRICT

MINUTES OF REGULAR MEETING OF BOARD OF SUPERVISORS Thursday, July 10th, 2025, at 8:30 AM

1. Call to Order

• The regular meeting of the Freeborn County Soil & Water Conservation District (SWCD) was called to order by District Chairman Helland at the district office located at 1400 West Main Street, Albert Lea, MN on Thursday, July 10th, 2025, at 8:30 AM.

2. Approval of Minutes

• A motion to approve the minutes of the previous meeting on June 12th, 2025, was made by Lightly and seconded by Kramer. **MOTION CARRIED.**

3. Treasurer's Report

Heers reported that the balance in the checking account was \$9,967.19, savings \$832,948.62, CD (10 month) \$250,000.00, and CD (10 month) \$235,000.00 as of June 30th, 2025. A motion to approve treasurer's report and payment of bills was made by Kramer and seconded by Lightly. MOTION CARRIED.

4. Southeast Services Cooperative Membership

Cornell brought before the board for consideration a renewal in membership with the Southeast Services
Cooperative. A motion was made by Heers to pay the \$325 membership fee for the Southeast Services

A motion was made by Kramer to extend offer to the first choice at \$29 an hour pending clearance of background check, with back-up options of the second choice at \$29 an hour and third choice at \$24 an hour, seconded by Heers.
